Daughter Project Girls Home (DPGH) Short Term Residential Therapeutic Program (STRTP)

Organization

Global Family is a non-profit organization operating in the USA and around the world. Founded in 2007, Global Family & the Daughter Project aims to protect children and preserve families by providing alternative, family-based care for children who are abandoned, abused, and exploited. We have created several initiatives outside the scope of direct family care, including the prevention and intervention of human trafficking, and the promotion of local and asset-based community solutions around the world using media to change perceptions around women and their rights in society.

The DPGH STRTP provides crisis and intervention care for individuals who are identified as commercially sexually exploited children (CSEC). The shelter home provides specialized services that meet the complex needs of CSEC as well as a safe environment conducive to healing from any trauma. No child should be in a circumstance where they are displaced from a home, vulnerable to being out on the streets, and thus vulnerable to further exploitation, abuse, neglect, and/or commercial sexual exploitation or trafficking.

Position

The Director of Mental Health will play a pivotal role in Global Family's DPGH STRTP operations. The Director will administer and supervise the mental health program of the STRTP and oversee the Kern Behavioral Health and Recovery Services (KBHRS) annual contract.

The Director will report to the Kern County Director.

Responsibilities

The Director of Mental Health will ensure efficient operations of the DPGH STRTP mental health services.

Responsibilities include, but are not limited to:

- Oversight and control of the DPGH STRTP mental health services. Organize the work of the facility and delegating responsibilities to staff.
- Develop a plan for the orientation, development, and training of staff. Provide and/or schedule training and continuing education to mental health employees and volunteers.
- Observe and interact with staff, clients, and other individuals, as necessary, to ensure the quality of care for children and program services.
- Serve as the DPGH STRTP representative for KBHRS.
- Oversee and maintain regulatory and compliance requirements; and audit internal programs.
- Assess the facility operations and program; and identify strategic initiatives for program improvement.
- Oversee and negotiate KBHRS mental health budget.
- Develop and maintain relationships with county agencies and officials.
- From time to time, provide direct service hours with clients.
- Develop or implement the written policies, procedures, and practices for continuous quality improvement.

Qualifications

- Master's Degree from an accredited college or university and a valid license (LCSW, LMFT, RN, or other), plus one year administrative or supervisory experience over social work, child care, and/or support staff providing direct services to youth in an agency serving children.
- Experience working with CSEC and at-risk youth, preferred.
- Excellent verbal and written skills, as well as organizational skills, attention to detail, and ability to be self-motivated and disciplined.
- Excellent time management skills and abilities to multi-task and prioritize.
- Knowledge in software applications including, but not limited to, Word, Excel, and PowerPoint.
