IMPORTANT NOTE: The child is called the "User" in this contract. This is because in my experience 1) teens feel belittled by being called a child, and 2) the term "User" implies a sense of responsibility.

IMPORTANT TEACHING OPPORTUNITY: This contract is also designed to help the parent teach important life lessons; as such, the first section is all about highlighting the life lessons that you want your child to learn by being using social media.

Don't just give this contract to your child to read over and sign. Sit down with you child; read over each section and thoroughly explain the important concepts of that section (this is why I want both child and parent to initial each section).

My hope is that this contract provides the structure you need to talk to your child about responsible and healthy social media use. Enjoy!
